- CONTRACT SUM AND PAYMENT TERM The Contract Sum is exclusive of taxes and subject to the addition of any and all applicable service taxes, value added taxes, sales taxes, duties and levies at the rate from time to time in force which shall be paid by the Buyer. If the Buyer is required under the law to deduct or withhold any sum as taxes imposed on or in respect of any amount due or payable to JC1, the Buyer shall be responsible to make such deduction or withholding as required but the net amount payable and remitted to JC1 shall be equal to the amount JC1 would have received in the absence of any such deduction or withholding. Unless otherwise agreed between JC1 and the Buyer, should (i) the Delivery Date or Installation Date be beyond three (3) months from the date of the Contract and (ii) the cost to JC1 of supplying the Goods and/or Services be increased by any circumstances of any kind whatsoever beyond the control of JC1, including without limitation, to increased production cost of manufacturers or suppliers/subcontractor, variations in rates of exchange, devaluation of any relevant currency or increase in relevant rates of freight or insurance, JC1 shall notify the Buyer of such increase and the Buyer shall bear such increase, in addition to the Contract Sum.
